## CHAPTER I

## ORGANIZATION AND ADMINISTRATION

During the first half of this reporting period, the administrative framework of the squadron remained the same as was evident in the last period. However, the squadron was reorganized under Table of Organization and Equipment No. 1-1213, dated 24 March 1948, on instructions issued in Sec. III, General Order 16, Hq 332d Fighter Wing, dated 25 August 1948 1/. The current change became effective 26 August 1948, however, because of the present participation of the major sections of the squadron in 9th Air Force's Operations Combine III at Eglin Field, Florida, the complete reorganization has not been realized.

At the close of the period, no visible problems had presented themselves as a result of the reorganization.

The unit mission remained the same as that of the preceding reporting period, however, many more missions were assigned by higher headquarters which consisted of rendering air-support to ground activities.

There was a temporary change in station for forty (40) percent of the enlisted personnel and ninety-five (95) percent of the aircrews, who departed the home station, 30 August 1948, for Eglin AFB, aux #7, Eglin Field, Florida, for participation in Operations Combine III. The temporary duty at Eglin #7 is contemplated until 10 November 1948, at which time, all personnel will return to the home station. 2/

## CHAPTER II

## PERSONNEL

As far as the strength of the squadron was concerned, the officer section still had shortages as contrasted with the small overage in the enlisted section. The strength report for the period was as follows:

No warrant officers, WAFS, nor civilians are authorized this organization. The variations in the above authorized strength totals since 1 August 1948, were due to the recent reorganization of the squadron under TO & E 1-1 13 as of 26 August 1948. 3/ The variations in the assigned officer strength columns were due to a shortage of fighter pilots, single engine (SSN 1055). This shortage has been most prevalent since the squadron was activated fifteen months ago, and although Wing Headquarters has stated many times that additional pilots would be assigned, this shortage has continued to place a strain on the available pilots in carrying out the assigned missions. Also, the fact that all but one

of the various technical and administrative jobs in the squadron are held by aircrew members adds to this personnel problem. Of course, as a temporary solution to the problem, all assigned pilots perform duties of aircrew members, in addition to whatever other administrative or technical duty held.

During the entire period, there was an overage in enlisted personnel, however this overage is being rapidly reduced by the numerous transfers of personnel to other bases and to oversea assignments.

For the first two months of the reporting period, the Commanding Officer, Captain Elwood T. Driver, was still on temporary duty at the Air Tactical School, Tyndall Field, Panama City, Florida, however the squadron was placed under the command of Captain Joseph D. Elsberry, who proved to be a most capable successor. 4/ The other key positions in the squadron were held without changes, except in two cases, those of the communications and S-1 sections. The former communications officer, First Lieutenant Jack Chin was replaced by First Lieutenant Samuel W. Watts, the latter having recently completed the officer's communications course (0200) at Scott Field, Ill. This represented great progress for the unit. In the S-1 section, First Lieutenant Allen G. Lane was replaced by Second Lieutenant William Clark, Jr. 5/ This latter change affected the unit in that an additional officer was assigned the squadron whose duties would be purely administrative, thus relieving Lt. Lane for flying as

his primary duty. A roster of the key personnel for the period is as follows:

The above roster indicates those personnel who held the key positions as of 31 August 48, also of 30 September 48, excepting in the case of the commanding officer, where Captain Elwood T Driver resumed command as of 20 September 48 in the temporary absence of Captain Elsberry. Lt. William E Clark, Jr. replaced Lt. Lane in the S-1 position, and Lt. Samuel W Watts, Jr. replaced Lt. Jack Chin in the position of Communications Officer, both replacements being made during August.

Of primary importance during the latter half of this period was the departure of personnel, this organization, to various technical schools which would give the much needed skills necessary in carrying out the squadron mission. As was brought out most forceably in the last report, the majority of the men performing duty as crew chief (SSN 750-B) could not be reclassified and given the proper Military Occupational Specialty for that position because of the lack of an additional specialty in the

maintenance field. This additional specialty is required by the AF Classification Manual 35-O-1, and although many attempts were made to set up a training unit on the station for this purpose, the lack of adequate training facilities precluded same. Fourteen (14) enlisted personnel departed the station for technical schools, of which were the following: 6/

It is believed that future quotas will be allotted this organization at the above rate, and if so all personnel will receive the required technical training in the very near future.

The picture of the officer personnel regarding duty at technical schools was somewhat different, however, as mandatory quotas for the Air Tactical School were the only ones which would bring really needed

training as far as the unit is concerned. Three aircrew members returned from Tactical school during this period, including the unit commander. One officer departed for Chanute Field, Hantoul, Ill, for a thirty-two (32) weeks, weather officer's course 7/, and another aircrew member was on temporary duty at Lowry Field, Denver, Colo., for the entire reporting period attending a twenty week photographic officer's course. Neither of these latter two courses will bring back any significant training as far as aiding the accomplishment of the unit's mission is concerned. What was hoped for by the command, was that the aircraft maintenance officer be detailed to a school of that nature as this training is much needed.

The Station Training Program as setup under the provisions of TAC Regulation 50-44, dated 1 July 1948 has done much to improve the proficiency of all personnel undergoing training. As of the end of the reporting period, the percentage of completion of training for those personnel not skilled in their proper MOS was as follows: 8/

Of note is the fact that the men, who were undergoing training in the 684 specialty were striving for the award of the SSN 750-B, crew chief. They are skilled 747-Bs and their training was greatly hampered because of the lack of adequate training facilities on the station which would provide them with some training in an additional specialty in the aircraft maintenance field.

Also adding to the problem of station training was the fact that in the past large numbers of personnel have been departing the station for long temporary duties elsewhere. This necessitated the suspension of the training and consequently, brings on a lull in the progress of the training.

Sixteen enlisted personnel were recommended for appearance before a classification board after having been deemed fully trained by the commanding officer, however, official orders have come down on but one awarding the new authorized MOS. Action on the others is expected shortly.

No officer personnel received changes in primary SSN.

The court-martial rate took an upward swing during this period. There was a total of six cases, of which, there were four (4) summaries,

one special, and one general. The command attributes the rise in the rate to the fact that the unity of the organization was disrupted somewhat by the various temporary duty periods at Eglin Field, Fla. It will be a major project in the future to control this situation.

The venereal disease rate was more along that which is demanded by the squadron commander. There was one case for the three month period, however, it is the duty of each individual in the organization to watch closely his personal hygiene at all times to keep all such disorders in check.

Special service activities, during the reporting period were at a minimum due primarily to the fact that the majority of the squadron was on TDY at Eglin Field, during the first month of the period for the gunnery program, and during the last month for Operations Combine III. Because of the physical setup of the auxiliary field at which the units were stationed in Florida, the showing of class "B" films, volley and softball playing provided the major forms of recreation.

At the home station, the remainder of the unit which was left behind carried on a vigorous beautification program on the squadron dayroom.

The morale of the squadron was very high, however, after the return to Florida, there was evidence of a drop as many of the departing personnel have their families in the Lockbourne area. In spite of the latter, however, the unit commander estimates that ninety percent of the EM, who are eligible for separation will reenlist for further military service.

## CHAPTER III

## SUPPLY AND EQUIPMENT

The supply and equipment section received much attention during the period, the reason for this being the changeover to new supply procedures and to a new TO & E. This latter change was effected 26 August 48, however, there have been no visible increases in efficiency. <sup>9/</sup>

During the early part of the year, the allowable authorized supplies were set at eighty (80) percent of table of equipment in accordance with the AF's then existing policy of supply and equipment. Since that time, however, the unit may receive and keep on hand one hundred (100) percent of what is authorized by the TO & E. The following are the percentages of allowable authorized equipment the limit being eighty (80) percent: <sup>10/</sup>

It is believed that the above percentages will increase sharply during the next period because of the special emphasis placed on the subject by higher headquarters.

The lack of an Aircraft Jack 3200 30-163 Kit, during the last period is no longer of much concern as the complete kit was received during this period. The outstanding shortage was:

7800-732 860 Stand Assembly-Portable Hydraulic Tester. Although, the proper requisition was submitted quite some time ago, no action by

has been taken by the 56th AF Supply in completing it. The above problem ceased to exist when one such unit was borrowed from another squadron. The tester borrowed was believed to be inoperative by the landing squadron, however, after the display of a bit of ingenuity on the part of one of the men in the technical supply section, the inoperative tester has been put to good use.

There was only one instance of defective equipment in the case of a tire casing on the main gear of a squadron ship. The tire blew out during the takeoff roll which resulted in a major aircraft accident off the end of the runway. 11/ The tire was condemned after seventy-three (73) days of use during which time fifty (50) landings were made. The tire was the ice-grip type which was being tested for hot weather operation. It had proven to be very successful during Arctic operations, however, after this accident, an Unsatisfactory Report was forwarded and instructions were received from Air Materiel Command at Wright-Patterson Field to replace all icegrip tires with those of standard stock.

Along this line of defective equipment, in the case of another major aircraft accident sustained, a broken weld was found at the upper air chamber of one strut and the down lock assembly of one of the main landing gear. 12/ The gear failed after the aircraft had run off the runway into some soft sand and the above defect was listed as the probable cause for the collapsing of the gear. No checks of this weld could be made on routine inspections as it was a part of the internal structure of the strut. The proper unsatisfactory report was forwarded.

## CHAPTER IV

## MAINTENANCE

The maintenance section did not undergo the complete reorganization as was brought about by the new TO & E, the reason being the fact that one half of the personnel was on temporary duty in Florida during the majority of the period. The physical setup of the temporary duty field precluded the assignment of more personnel from the home base even though the commitments for Operations Combine III required every available man. The completed reorganization of this section should be effected during the following period after the squadron returns to the home station.

As was brought out above, the commitments of the squadron as far as Operations Combine III was concerned necessitated a change in the organization of the maintenance section even though this change did not conform with current TOs. There were many experienced men who had to be left at the home station because their current enlistments were expiring. These men were to depart the station either on separation leave or permanently. There were other men who had departed for technical schools and who could not be counted on for an indefinite period. The men who were available for the extended temporary duty in Operations Combine III were not the most qualified assigned the squadron. This problem was solved by the maintenance officer by resorting to the aircraft maintenance crew, which consisted of grouping all the qualified specialists in one unit and having them move from one aircraft to the other and perform all required inspections and enough of the maintenance necessary until the crew chief concerned could step in and complete the job without difficulty. The effectiveness of this procedure was immeasurable.

Of note is the fact that the service stock section of the 56th AF Supply still lacks sufficient trained personnel to keep an accurate classification and account of all items of supply on hand. Many man hours were often lost to the maintenance section as many times crew chiefs had to wait until the technical supply NCO could track down the requisition, and find out why the item of equipment had not been returned. 13/

The outstanding problem of the past still exists, that of the lack of sufficient trained maintenance personnel, however, this problem is being corrected somewhat as quotas are being received in sizeable numbers for the various technical schools (see chapter II).

The new maintenance procedures adopted included the discontinuance of the oil clarification procedures on verbal directive of the 9th AF Technical Inspector. The Brig's Portable Filtering and Clarifying Units, MC-1, 2, 3 covered in Technical Order 01-1-213 dated 19 November 45 are no longer manufactured, which now requires the change of all oil at each fifty (50) hour inspection. 14/

On the subject of inspections, due to the continuous flying during the Operations Combine III, all aircraft inspections made were running inspections. This was a system which allowed some of the necessary inspections between missions flown, and prevented the grounding of the aircraft for long periods of time when they were very much in need.

Outstanding maintenance jobs accomplished included the removal of the entire empennage section from an F-47N because the services of the

aircraft were very much in need, and at the time, the Field Maintenance Activity had a large back log of work, which precluded any immediate action on this particular aircraft. Also, there were the cases of six (6) propeller power plant units which were completely overhauled. This was done because of the fact that essential new parts were not available from the 56th AF Supply, and the lack of these parts was causing the aircraft concerned to be carried in an out of commission status.

Much credit is due the maintenance chief, who invented a test unit for testing tachometer generators for serviceability while installed on the aircraft engine. This test unit proved to be an excellent air in trouble shooting mal-functions of the tachometer generator system. It also prevented the loss of much time and maintenance, also the necessity of shipping the unit back to the factory for checking.

The daily percentage of aircraft in and out of commission on a monthly basis was as follows:

The sharp decline in the percentage of aircraft in commission during August can be attributed to the fact that much maintenance was required on the aircraft after the squadron returned from the gunnery program in July. Also, the aircraft were being readied for the forthcoming Operations Combine III.

During the last period, the fact was brought out that there was a delay in the installation of AN/ARC-3 radio sets in the aircraft because of the delay in receiving the equipment from 56th AF Supply. It can be

noted here that there was a complete installation of these sets during the period. This brings about a happy condition as far as flying training is concerned. There was also, during the last period, a shortage of "C" channel crystals, however, at the present time, the squadron is well stocked with all types of required crystals.

The personnel situation is not so beautiful, however, in the communications section, as there was a fifty (50) percent shortage of qualified personnel. This condition necessitated the maintenance during the past major operations of all of the aircraft radios by the few personnel assigned, however, this was done without lowering the high standard of maintenance.

Armament difficulties were centered around shortages of G-9 gun solenoids during the previous period. At the close of this period, this condition has been relieved as a large supply of these items of equipment are now available for issue.

## CHAPTER V

## TRAINING

The major training during this period consisted of training for aircrews. There was the continuous training for all personnel in the squadron, however, this type suffered somewhat because of the two moves of the unit. Also, as was brought out in chapter II, this report, the Station Training program as set up under TAC Reg 50-44 received a sharp setback because of the lack of adequate training facilities for the majority of those requiring the training.

Under continuous training, chemical warfare lectures were outstanding. One lecture was held each month by a qualified chemical warfare officer. Because of the six weeks stay at Eglin auxiliary #7, Florida, physical training, in the form of softball, volley ball, and touch football played an important part in the continuous training.

Outstanding in this chapter will be the training received by aircrews, who were continuously participating in some type of mission which would add to the proficiency of the individual pilots and flight commanders. The most important of these missions concerned joint operations with the ground forces. Of these, four missions were flown, totalling sixteen (16) sorties in conjunction with "Operations Pointer" at Ft. Bragg, North Carolina. The aircrews were based throughout the exercises at Pope Field, N.C. <sup>15/</sup> During these exercises, the unit performed dive bombing with two hundred and fifty pound general purpose bombs.

At Ft. Knox, Ky, squadron aircrews, which were based at Godman Fld, Ky., participated in similar missions for the Armored School. Air ground support was provided a battalion of Infantry in attack with the use of 250# GP bombs, 5" HVAR rockets, and the firing of .50 cal. ammunition. Screening smoke was also placed upon the direction of the ground controller. Thirty-six sorties were flown, all of which were highly successful.

Excellent training is received by all personnel concerned from the above type missions, also, operations personnel receive much training in the planning which is necessary for a good show and at the same time observing all safety precautions.

The 9th AF operations 200 missions were suspended in the most part during the period. However, two (2) control missions were flown with a total of eight (8) sorties. This latter type mission also adds much to the pilot proficiency even though no live ordnance is used.

Of the flying training scheduled, ninety-five (95) percent of the aircrews completed eighty (80) percent, the other five (5) percent completed only fifty (50) percent. The retarded progress of the five (5) percent who have completed only fifty percent is due mainly to the fact that these pilots have just recently returned to active duty and it was necessary for all of them to be checked out in the T-6 aircraft and regain some of their lost proficiency before starting on the tactical aircraft. 16/

Another reason for the retarded progress of these aircrews was the

fact that eight pilots had to receive transition in one (1) T-6 aircraft<sup>2</sup> available to the squadron. To compensate for this lack of enough transition aircraft, every available minute was used to check out these returnee pilots which almost suspended entirely the dual rides in the instrument training program. Instrument flying was restricted to fighter instruments and to that which would be received in the line trainer, excepting, of course, the required instrument checks, most of which were given in the T-6.

Ninth Air Force's Training Standard 10-1 and Air Force Regulation 60-2 received major attention throughout the period, and to date the majority of the aircrews have completed the requirements for the first half of the fiscal year 1948-49.

The story of aircraft accidents sustained during the period is a very sad one. In the first of five (5) accidents 17/, the hands of fate took from the organization one of the most respected officers on the base. During a landing after a routine night formation flight, the pilot of aircraft #4489217, was overrun by aircraft #4489089, the following aircraft to land. The standard operating procedure for night formation landings was observed by both pilots and an additional three hundred and sixty (360) degree circle was made by pilot #2. However, during an ensuing go around by pilot #2, his aircraft struck pilot #1's which was still on the runway, and a violent explosion followed. Pilot

#1, who was pinned in his cockpit, received fatal burns, and both aircraft were destroyed by the fire. Pilot #2 was able to clear his aircraft receiving only minor lacerations and shock.

Pilot #2 above was immediately suspended from flying duty pending appearance before a local flying evaluation board during the process of trying to determine the cause of the accident.

The above accident meant the loss of the squadron's most consistent pilot, also one of its much needed instrument instructors.

The third accident involved the loss of aircraft #4489900, which was loaned to the squadron while at Eglin auxiliary #6 to support the gunnery training program. During the approach for landing on 3 July 48, a piston was damaged causing a great loss of engine lubricating oil, which in turn caused engine failure. Although, the pilot of the aircraft was maneuvering to bring the ship down safely, because of his restricted visibility, and the loss of power, the aircraft settled down just short of the runway striking the soft sand and causing a gear to become sheared off. On the second bounce, the aircraft lost its other main gear and received other major damage to the engine and fuselage. No action was taken in that the cause for the damaging of the piston could not be determined.

As was touched upon in the maintenance section of this report, another major accident was caused when a tire blew out on the main gear of aircraft #4489046 during the takeoff roll on 12 September 48. Major damage was received by the aircraft when it continued to the end of the runway and dug in the soft sand. This was mainly a case of defective equipment (see chapter III, page 10).

The final accident was brought on when on 26 September, the pilot of aircraft #4489031, during a takeoff roll, was unable to get any response from his surface controls, and decided to cut his power and remain on the ground. The aircraft rolled off the end of the runway, and received major damage. One defective part was found in the landing gear, which, however was not a contributing cause of the accident. No cause could be found for the accident, consequently, no definite action could be taken. The appropriate unsatisfactory report was forwarded on the defective gear part.

It is of importance to note that, the aircraft accidents sustained during the period far outnumbered those sustained during the last reporting period, however, it is the opinion of the command that had the field in Florida been more adequate for the F-47 type aircraft, sixty (60) percent of the accidents would not have occurred.

## CHAPTER VI

## FACILITIES

As far as the temporary duty at Eglin auxiliary #7 was concerned, the landing field facilities were inadequate for the F-47. All pilots carrying bombs, 500# and 350#, were able to get off the ground at all times which was very well, however, had an engine failed immediately after takeoff, or after the first one half of the runway had been used, the chances of saving the aircraft from major damage were very slim. The clearances at the ends of all runways were conducive to accidents as was brought out in chapter V, this report. The detachment operations did as much as could be done with the available facilities, however, the situation was not corrected very much. Adequate briefings were given all pilots as to the possibilities of avoiding danger areas in and around the field should their aircraft get out of control at the end of the runway.

Other recreational facilities at Eglin #7, such as dayrooms and an officers' club were not available. Of course, the above situation did not lower the morale of the unit to any great extent because all personnel realized that the main idea was to get the mission accomplished, and the stay in Florida was only a temporary one. It was understood, also, that as far as possible, there would be a rotation of personnel at Eglin #7 with those left at the home station.

The beautification program of the squadron dayroom at Lockbourne received major attention by those on duty there. Many of the off-duty moments were spent by personnel left at the home station trying to complete the dayroom before the sections on maneuvers returned in November.

## CHAPTER VII

## S/SGT MAL WHITFIELD AT OLYMPICS

In that the whole world knows how S/Sgt Malvin Whitfield blasted six-tenths of a second from the old olympic record on August 2, when he captured the 800 meter run in 1:49.2, it is of importance now to record the very favorable publicity which his victories brought to the United States Air Force and to his unit. 18/

S/Sgt Whitfield, as the winner of the 800 meter run, became one of the few participants to receive three (3) winner's medals. The second received was the gold medal for the triumph of the 1600 meter relay team on which occasion, Sgt Whitfield provided a most outstanding anchor. In winning third place in the 400 meter run, Sgt Whitfield received his third of the day, a bronze award.

On all occasions when Sgt Whitfield was mentioned, it was Sgt Mal Whitfield of Lockbourne Air Force Base, Columbus 17, Ohio, a community proud of him in its entirety.

Sgt Whitfield spent many days of hard practice while a member of the organization, and although it was believed by all of his squadron mates that he was a certainty to win in the London games, deep down inside, many others who knew him gathered added hopes after considering the extra efforts put forth by him to make himself eligible for competition.

It is not definite at this writing whether Sgt Whitfield's native California will win out over the USAF at the expiration of his current enlistment, however, it is hoped that more in the military will strive and reach the heights as has just been done.

1. A HOT MEAL OF BEEF STEW WAS SERVED FOR BREAKFAST AND A COLD LUNCH WAS GIVEN EACH MAN. WE DEBARKED AT ABOUT 1130 AND PROCEEDED TO A STAGING AREA IN BAD LTO. WE MADE OURSELVES AS COMFORTABLE AS POSSIBLE IN A COLD BUILDING AND DINED ON FIELD RATION K AT NIGHT. WE FOUND SOLDIERS FROM ALL PARTS OF THE WORLD A GREAT INTEREST TO US. THE ITALIANS BOTHERED US ALL DAY FOR CIGARETTES AND FOOD. CAPTAIN THESVILLE CALLED A MEETING OF ALL DEPARTMENTS HEADS TO DISCUSS FUTURE PROBLEMS.

2. LT QUICK, SQUADRON INTELLIGENCE OFFICER, WHO HAD COLLECTED OUR AMERICAN CURRENCY ON THE BOAT, DISTRIBUTED INVASION CURRENCY TO US. ALL OF US WONDERED ABOUT THE WHEREABOUTS OF THE REST OF THE 32ND FIGHTER GROUP. WE ARE STILL EATING K RATIONS AND THE RAIN IS STILL FALLING. WE BEGAN OPERATIONAL FLYING TODAY.

6. AT LAST THE DRESS HALL IS FUNCTIONING AND WE HAD OUR FIRST HOT MEAL

THEY INFORMED ME THAT THEY HAD THE FIRST PICTURES OF THE HISTORY MAKING MEETING BETWEEN THE ALLIED FORCES, MAKING ANZIO NO LONGER A BEACH HEAD. THEY ASKED ME TO CARRY THE PICTURES BACK TO ARMY SPECIAL SERVICES OFFICES, LOCATED NEAR OUR FIELD, SAYING THAT I WOULD BE DOING THE PEOPLE AT HOME A GREAT FAVOR BY FURNISHING FIRST HAND PICTURES THAT OTHERWISE MIGHT BE DELAYED INDEFINITELY.
